Blackpool FC Community Trust (BFCCT) is the official charity of Blackpool FC, based at Bloomfield Road Stadium. Working with residents as young as two years old up to adults in the later stages of life, Blackpool FC Community Trust provide a diverse range of programmes to increase social inclusion opportunities; improve physical fitness, health, and education; and lessen involvement in anti-social behaviour.

Many of the initiatives we deliver are directly funded through partner organisations and grant-awarding bodies. Some of these include The Premier League; the EFL Trust; The PFA; Sport England; Big Lottery; The Football Foundation; NHS Blackpool CCG and Blackpool Council to name a few. BFCCT constantly evolves to support local need and by linking with local partners we can increase our impact on the town.

Working with so many organisations has allowed us to become a vital strategic partner in activity provision across Blackpool and the Fylde Coast. In addition to the wealth of programmes out in the community and local schools, BFCCT provide several education opportunities on site. Job Purpose

Blackpool FC Community Trust is the official charity of Blackpool FC, based at Bloomfield Road Stadium. Working with residents as young as 2 years old up to adults in the later stages of life, BFCCT provide a diverse range of programmes to increase social inclusion opportunities; improve physical fitness, health, and education; and lessen involvement in anti-social behaviour.

In recent years the Trust has grown significantly and has become an established organisation, providing something for everybody, that every Blackpool FC fan and resident should be involved in and very proud of.

Blackpool FC Community Trust is seeking a dynamic and dedicated individual to join our Community Programmes team as the Community Cohesion Manager. This is an exciting opportunity to take the lead in coordinating, planning, delivering, monitoring, and evaluating impactful youth activity programmes. The successful candidate will be responsible for managing a team of six full-time staff, four part-time staff, and a bank of casual staff, as well as overseeing a budget in excess of £350,000. This budget will be used to develop, manage, and sustain these essential programmes, ensuring their ongoing success and impact.

Central to the role are the Premier League (PL) Kicks and Holiday Activities and Food (HAF) programmes, which focus on engaging and inspiring young people through positive, diversionary activities, interactive workshops, and social action initiatives for young people in targeted areas across Blackpool.

The Community Cohesion strand includes a range of programmes aimed at engaging a diverse audience, with a primary focus on reducing and preventing antisocial behaviour (ASB) and crime. This involves managing the Champions and Tower Above initiatives, which deliver tailored one-to-one support for young people and young adults. By harnessing the transformative power of sport and personalised mentoring, these programmes seek to build positive relationships and empower young people and young adults to achieve their aspirations and access meaningful opportunities for growth and success.

The post holder will be responsible for managing cohesion and youth sport delivery staff and accountable for making sure all KPI's and targets are met for all programmes within their remit. Ensuring high quality monitoring and evaluation methods and techniques are in place is a crucial component of this to meet the needs of the commissioners and target audience.

The post holder will also work alongside the Deputy CEO to develop funding proposals as well as respond to reports for partner agencies and commissioners.

Blackpool FC Community Trust, based at Bloomfield Road Stadium and is the official charitable arm of Blackpool Football Club, with a focus on engaging, developing, inspiring and supporting the people of Blackpool to live better lives.

Main Roles and Responsibilities

- Manage and oversee the PL Kicks project, running every weekday evening, and the PL Kicks HAF
 programme, delivered during half-term both during the day and evenings.
- Manage and oversee cohesion programmes, including Champions, Tower Above, and any newly developed projects within this strand.
- Screen Champions and Tower Above referrals and appropriately allocate them to staff caseloads.
- Provide line management for a team of full-time, part-time, and casual staff.
- Conduct quarterly one-to-one performance reviews and offer ongoing line management support to promote staff well-being.
- Identify, recruit, and manage volunteers through internal and external relationships.
- Ensure project reports and data are submitted to a high standard in line with set targets and KPIs with all M&E and admin being kept up to date.
- Engage new participants through community outreach, events, and collaboration with partners.
- Maintain and develop relationships with key partners and stakeholders, such as PLCF, Blackpool Council, VRN, Police, and Blackpool Youth Partnership Provision.
- Manage relationships with local colleges and sixth forms, ensuring high standards in delivery and partnership management.
- Develop targeted interventions with partners to engage specific groups identified through insight.
- Work with the Deputy CEO to identify and secure new funding opportunities.
- Ensure projects are delivered within budget expectations.
- Submit project reports and data to a high standard, meeting targets and KPIs, while maintaining upto-date monitoring, evaluation, and administration records.
- Ensure all activities and sessions are safe, suitable, and inclusive for all participants.
- Supervise and support delivery officers and volunteers to ensure adherence to protocols and safe delivery standards.
- Carry out necessary administrative tasks, including maintaining staff records, registers, and quality assurance documentation.
- Work with the media team to develop and share regular, varied communications content across internal and external platforms.
- Attend local, regional, and national events and network meetings to represent BFCCT.
- Ensure the safety and well-being of all participants in Community Trust activities by adhering to Health
 & Safety guidelines and safeguarding policies.
- Adopt an accessible and flexible approach to fulfilling the role, including working unsociable hours, evenings, and weekends, as required.
